

## DRAFT BUDGET FOR FISCAL YEAR 2011-12 PRESENTED

Court members received, as regulated by Kentucky statute, a draft of the proposed budget for Nelson County for Fiscal Year 2011-12. Judge Watts also presented a chart showing assessed value of properties since 1993 and the increase in growth in property values since from that time each year until the current year. During the past three years, growth has decreased significantly; end result is that expenses are rising and the revenue stream has leveled off or decreased in certain areas. Following discussion of anticipated increases and potential cuts, e.g., moving certain positions to part-time, Court members were asked to consider the draft budget for action at a future meeting.

## EMS FEE INCREASE APPROVED

Court members were asked at the previous meeting to consider adjusting EMS rates by 5% in order to qualify for increase in Medicare rates based on the "usual customary charge". Ambulance service is subsidized through taxpayer dollars in Nelson County in the amount of between \$200,000 to \$300,000; it is deemed in the best interest of the taxpayer to be able to recoup some of this funding. Court members were presented a comparative chart of rates charged in surrounding counties:

Revision based on other county charges, Possible Medicaid Reduction, and increased Fuel Cost  
Nelson County EMS' last rate increase was March 2008

Joe Prewitt explained to Court members that any increase in Medicare rate of reimbursement happens only after several months from the time those rates are approved. Also, Medicaid will no longer be co-insurer for patients who receive Medicare insurance. On motion of Jerry Hahn, second by Jeff Lear, by unanimous vote of the Court, IT IS HEREBY ORDERED to approve an increase in EMS fees, effective May 1, across the board, as recommended by the EMS Director and by the County Judge-Executive.
