AGREEMENT - BLUEGRASS CELLULAR

On motion of Bernard Ice, second of Sam Hutchins, by unanimous vote of the Court, IT IS HEREBY ORDERED to enter the following agreement as a matter of record (See Book 37, Page 112):

AGREEMENT REGARDING ENCRoACHMENT PERMITS IN NELSON COUNTY, KENTUCKY

WHEREAS, Bluegrass Network, LLC, Kentucky Limited Liability Company whose principal place of business is located at 2902 Ring Road, Elizabethtown, KY 42702 (hereinafter "Bluegrass") desires to place fiber optic cable (cable) within the right of way of certain roadways within Nelson County, KY;

WHEREAS, the Nelson County Fiscal Court (hereinafter County of Nelson) whose mailing address is P.O. Box 578, Bardstowm KY 40004 is concerned that the placement of said cable in the right of way may interfere in the future with persons seeking to obtain entrance permits to their land by requiring the movement of the cable that Bluegrass seeks to install;

WHEREAS, Bluegrass is willing, at its own cost, to move its cable if necessary to facilitate the granting of any entrance permits requested on said roads;

NOW, THEREFORE, for and in consideration of the mutual promises made herein by each party, the parties agree as follows:

1. The County of Nelson will grant unto Bluegrass Network, LLC encroachment permits for both buried and aerial fiber optic cable within the right of way along and across the following the roadways in Nelson County, Kentucky: Breezy Way, Pottershop Road, Ora Brent Road, Ed Brent Road, Hutchins Lane, Old Sutherland Pike, Sutherland Road, Hubbards Lane, Hugh Ice Loop, Hardin Leslie Road, Bennett Lane, Clear Creek Drive, and Lick Creek Lane;
2. Bluegrass, and it agents, successors and assigns, guarantee that Bluegrass shall pay the entire cost of relocating any such cable line that is placed in the County right of way that may need to be relocated in the future to facilitate any entrance permit issued by the County. Bluegrass and its agents, successors and assigns shall hold both County of Nelson and any private property owner harmless from any costs associated with relocation of said cable line(s).
