WHEREAS, Nelson County's 2,750 4-H participants and 250 volunteers are celebrating 109 years of positive youth development programming; and



Whereas, Jack R. Allen has been an agent with Kentucky Farm Bureau for over 50 years in Nelson County, Kentucky, and;


Whereas, Jack R. Allen has contributed to the business and civic community in Nelson County while serving as the local Farm Bureau agent, and;
