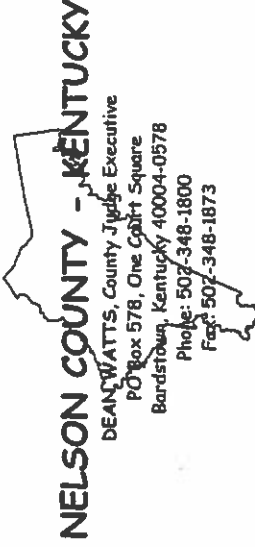

2015-16 PROPERTY TAX RATES DISCUSSED

Information regarding 2015 tax assessments was presented to members of Nelson Fiscal Court, as well as spreadsheets showing estimated receipts if compensating rate is used to set taxes or showing estimated receipts if a 4% increase is levied. Court members were asked to consider these figures for action at a later meeting.

RECREATION

****HISTORY** - Judge Watts presented to Nelson County Court a summary of the history of Nelson County's involvement and participation with the City of Bardstown, with the County's agreement with then-Mayor Dr. Harry Spalding to absorb capital costs related to purchase and development of a recreational facility on Spencer Mattingly Rd., with the county to contribute some funding for operational costs (\$100,000 annual contribution included in annual county outlay). Judge Watts told Court members that last October/November, the County got the "pink slip", with figures put out by Mayor John Royalty saying "that the city contributes more than \$590,000 annually to fund the joint recreation program, whereas the county contributes \$100,000 and the facilities at Dean Watts Park, though the parks fields are maintained by the city recreation department", as quoted by Nelson County Gazette. Judge Watts explained that he had never been able to receive figures verifying the City's \$590,000 expenditure; in fact, the City's budget shows its expenditures of \$307,028--the difference between total expenditures and total revenue for recreation for 2014. He also presented an itemized accounting of Nelson County's recreation expenditures for FY 2014 - total outlay amounted to \$426,737.65. County's outlay at the park to date was itemized as follows:

Following his remarks concerning contributions toward recreational programs over the years both by the City of Bardstown and the County of Nelson, Judge Watts stated that "going forward, with regret, the County is going to move forward with recreation solo. The \$100,000 that has been allocated to the City will now be used for mowing, striping, etc.; advertisement has been done for a Rec Director. Bleachers at the Fairgrounds that are used only in the month of July will be used in the interim at fields at the park where necessary. Court members generally expressed sorrow at this turn of events, saying that citizens deserve better and noting that, long-term, youth suffers. Keith Metcalfe stated that he, as a member of the Rec Board along with Jeff Lear, and with the help of Brad Spalding, intend to move forward and get the situation lined out, and he asked the community to bear with the Court.

****FIELD STRIPING CONTRACT** - Brad Spalding opened his comments by paying high compliments to City staffers with whom he had worked at the park. Going forward, football, soccer and baseball fields must be striped. Bids have been received as follows:
