On motion of Ex. Bobby Boblitt, seconded by Ex. George Hunter, said motion carried unanimously that we pay out of the Revenue Sharing account for patching material the amount of \$6,054.70 and that we further pay out of our Revenue Sharing account the amount of \$8,918.18 heretofore let on bid contract for the Resurfacing and blacktopping of certain roads in Nelson County.

On motion of Ex. George Cecil, seconded by Ex. Bobby Boblitt, said motion carried unanimously that the following be adopted:

An ordinance of the City of Bardstown, Kentucky, and an order of the Fiscal Court of Nelson County, Kentucky, by Agreement and in Joint Action, on Behalf of their Respective Entity, hereby Establishing a Bardstown and Nelson County Recreational, tourist and Convention Commission and Relating to the Levy, Fixing Rate and Collection of a Transient Room tax to Provide Funds For the operation of Commission herein Established.

Whereas Sections 83.340, 83.345 and 83.350 of the Kentucky Revised Statutes, authorized the establishment of a recreational, tourist and Convention Commission, and

Whereas the city of Bardstown and Nelson County acting jointly on behalf of their respective entity, have and hereby establish a Bardstown and Nelson County Recreational, Tourist and Convention Commission, and that said Commission has submitted its Annual Budget establishing a request for funds for the operation of the Commission for the calendar year of January 1, 1974 through December 31, 1974 in the total amount of \$10,500⁰⁰ all as provided by KRS 83.350.

Now Therefore, be it Ordered and Resolved by the Fiscal Court of Nelson County, Kentucky, and The Board of Council of the City of Bardstown, Does ordain as follows:

Section 1. That the Budget attached hereto and made a part hereof on the Bardstown and Nelson County Recreational, Tourist and Convention Commission requesting funds for the purpose of promoting convention and tourist activity is approved, confirmed and ratified.

Section 2. That to provide funds for the operation of said Commission there is imposed and levied a transient room tax of three per-cent (3%) of the rent for every occupancy of a suite, room or rooms, charged by all persons, Companies, Corporations or other like or similar persons, groups or organizations doing business as motor Courts, motels, hotels, inns or like or similar accommodations business, and that said transient room tax shall apply to transient guests who occupy a room in motor Courts, motels, hotels, inns or like or similar accommodations business for a consecutive period of thirty days or less. and said tax shall be levied and become effective on and after June 1, 1974.

Section 3. That all persons, Companies, Corporations or other like or similar persons, groups or organizations doing business as motor Courts, motels, hotels, inns or like or similar accommodations business shall collect and pay said transient room tax to the Commission at Nelson County, Kentucky.

Section 4. That the Treasurer of Nelson County upon receipt of said taxes, interest, and penalties shall forthwith remit same to the Treasurer of the Bardstown and Nelson County Recreational, Tourist and Convention Commission, provided that such remittance shall not be in a total amount greater than the Budget approved herein.

Section 5. That all ordinances, resolutions, orders and parts hereof in conflict herewith are hereby repealed to the extent of such conflict. And this ordinance, order and Resolution shall take effect and be in force upon Publications as required by law.
