Proof of the increased cost shall be documented by satisfactory evidence. Any proposed increase in the price of the material shall be submitted to the Nelson County Fiscal Court at least seven (7) days before the increase is to become effective, and the Fiscal Court shall have the right to cancel the purchase agreement or contract within seven (7) days of receipt of the notice of increase.
